

## **Supplement No. 01/2020 to the Remuneration Regulations of the St. Elizabeth University of Health and Social Work**

1. Due to the fact that on 01.01.2020 entered into force Government Regulation No. 388/2018 Coll. and the new salary grades are listed in Annex 5, the organization determines after approval by the Board of Trustees of the St. Elizabeth University of Health and Social Work For holders of the teaching titles of associate professor and professor, in accordance with Annex 5 to Government Decree No 388/2018 Coll. are set according to the resolution of the Scientific Council of the University of 01.10.2019 for all organizational components of the St. Elizabeth University of Health and Social Work ( „hereinafter referred to „SEU“) as follows:
  - **Class No. 11** - university teacher with the title of professor and Dr.h.c. after meeting the general criteria of the SEU for inclusion in the post of professor and after meeting the specific criteria - the draft standards of the Slovak Accreditation Agency for Higher Education ( hereinafter referred to as SAAVS )
  - **Class No. 10** - university teacher with the title of professor and the scientific rank of DrSc. after meeting the general criteria of the SEU and the specific criteria - the SAAVS draft standards
  - **Class No. 9** - university teacher with the title of professor and scientific rank PhD. or CSc., Dr. after meeting the general criteria approved by the Scientific Council of SEU and specific criteria - the draft standards of SAAVS
  - **Class No. 8** - university teacher with the title of associate professor and the scientific rank of DrSc. after fulfilling the general criteria of the Scientific Council of the SEU and the specific criteria- the draft SAAVS standards
  - **Class No. 7** - university teacher with the title of associate professor and the scientific rank of PhD. or CSc. , Ph.D. after meeting the general criteria of the SEU Scientific Council and the specific criteria - the SAAVS draft standards
  - **Grade No. 6**- University teacher with the title of associate professor or professor before meeting the general criteria of the SEU and before meeting the specific criteria - the SAAVS draft standards
  
2. In connection with the termination of the validity of the Regulation of the Government of the Slovak Republic on the Accreditation Commission on 31.12.2019, the function of the guarantor ceases to exist. The supplement for the function of guarantor is deleted. Instead, a personal allowance is set in relation to the publication activity in the past academic year in the categories ADC, ADD, ADN, ADM( scientific publications indexed in the databases Current contents, Web of science, Scopus, Medline) as well as a management allowance ranging from 100€ to 300€ according to the size of the workplace and 300€ to 500€ for the academic position of dean, vice-dean, rector and vice-rector.

This Appendix shall enter into force on the effective date of the cited Government Regulation, i.e. 01.02.2020.
