# ALIGNMENT OF QUALITY STANDARDS FOR HABILITATION AND INAUGURATION PROCEEDINGS

- **HI 5.2.1. The** University shall establish, implement and modify third-level study programmes in at least half of the fields of study in which it provides higher education.

**The SEU** has 6 fields of study: nursing, public health, health sciences (LVM, physiotherapy), social work, midwifery, psychology, sociology (abolished). Out of 6 disciplines, the University conducts study programmes in 4 disciplines (66%). The University is establishing doctoral programmes in four of the six disciplines except psychology and midwifery.

**HI 5.3.1 The** University undergoes periodic evaluation of its research, development, artistic and other creative activities in individual areas of research and has been granted permission to use the designation "research university" based on the results of the most recent evaluation.

The university will be able to undergo the evaluation only when the Ministry of Education and Science of the Slovak Republic provides an exemption for private universities, according to which they will be able to receive grants from VEGA, KEGA.

The University is also regularly subjected to international evaluation of research, development and other creative activities in individual areas of research.
